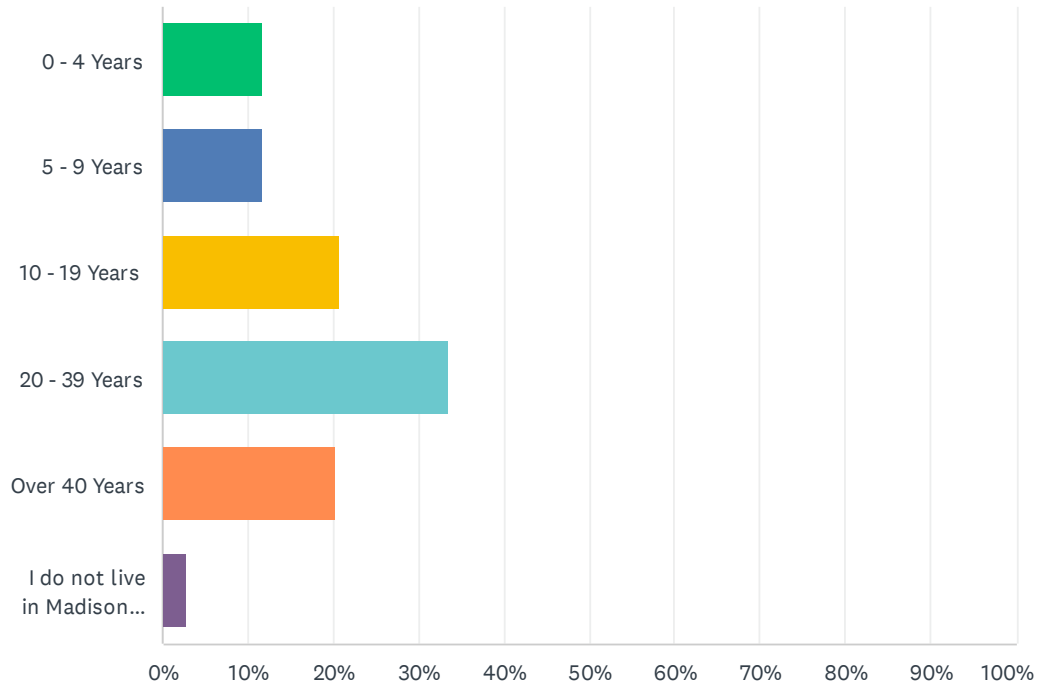

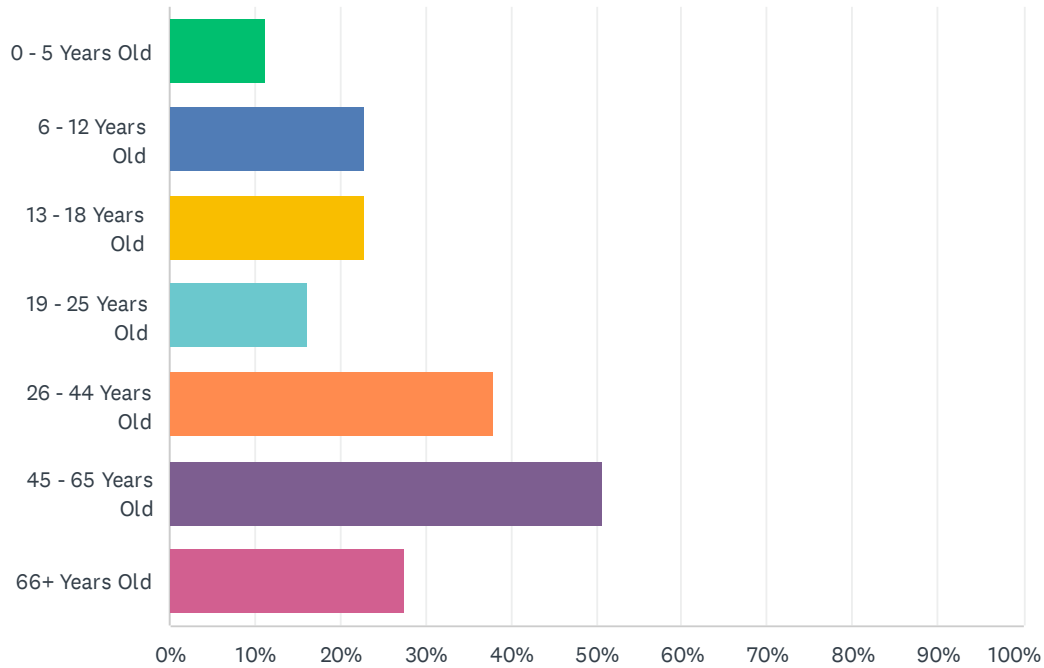

Q4 What are the ages of those living in your house? Check all that apply.

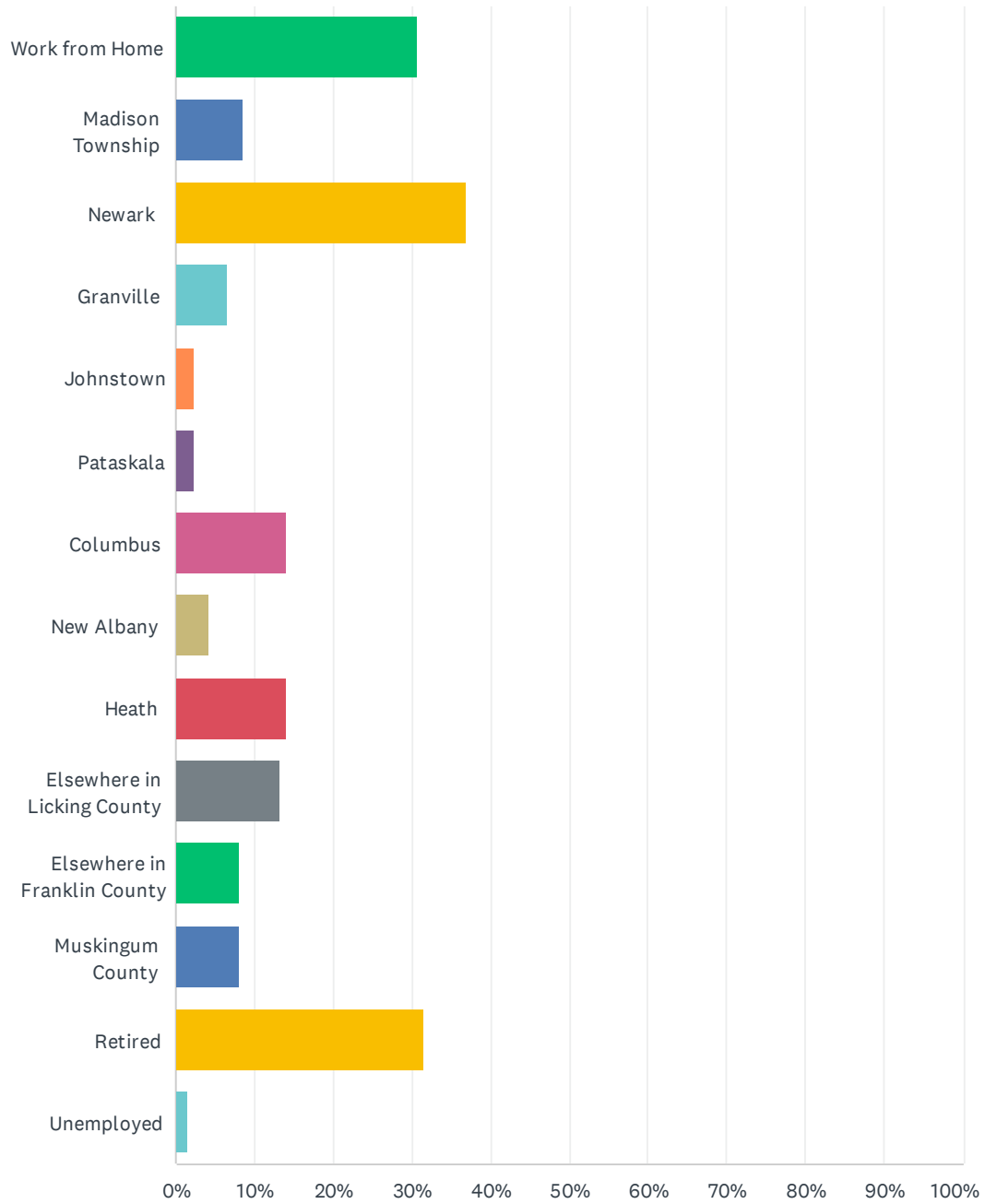

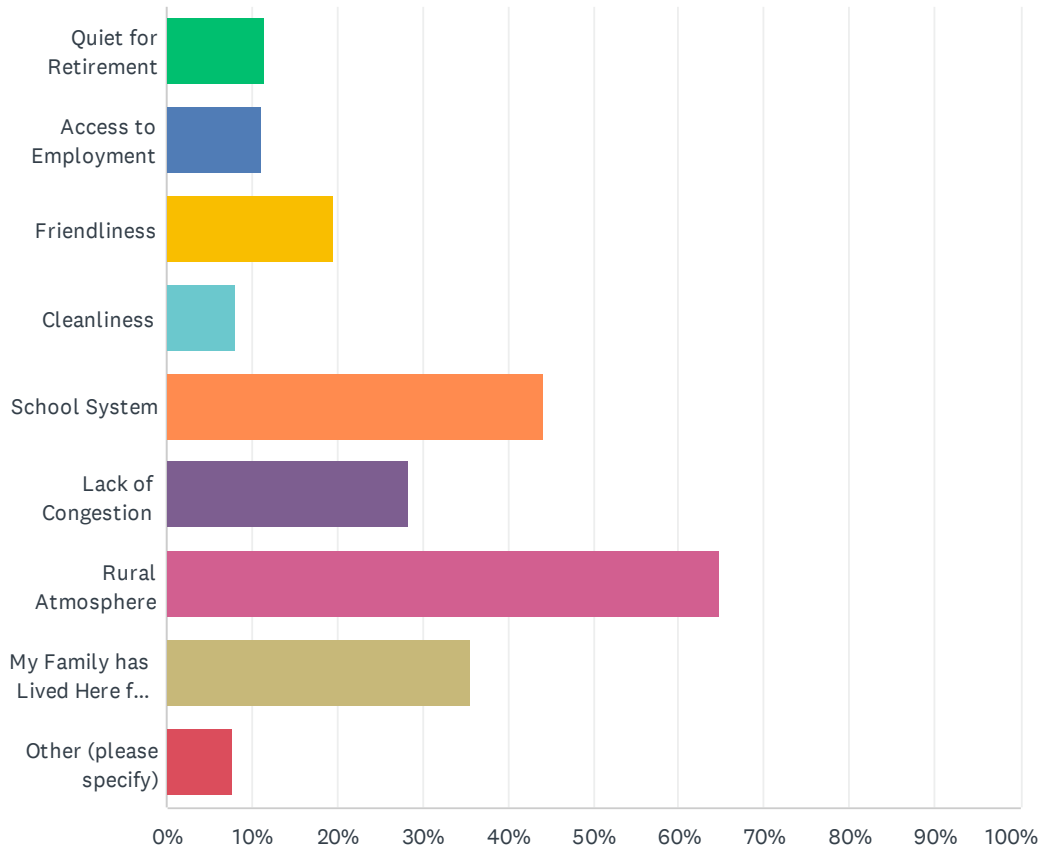

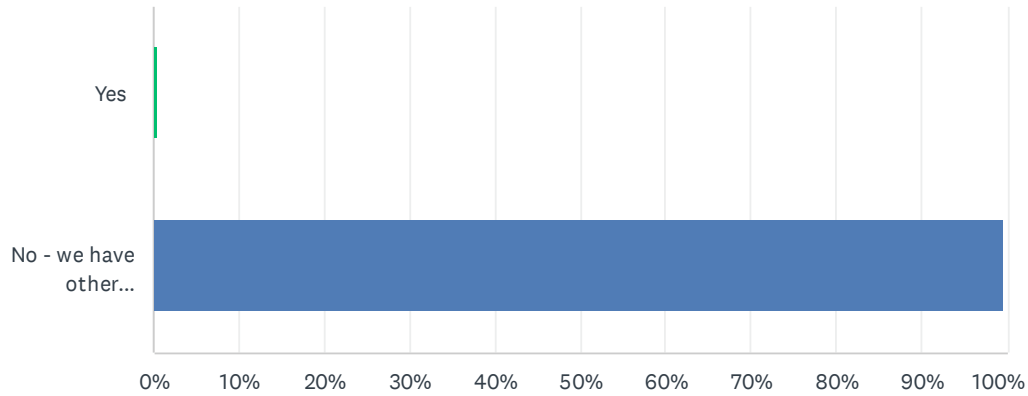

Q8 Is farming your family's primary source of income?

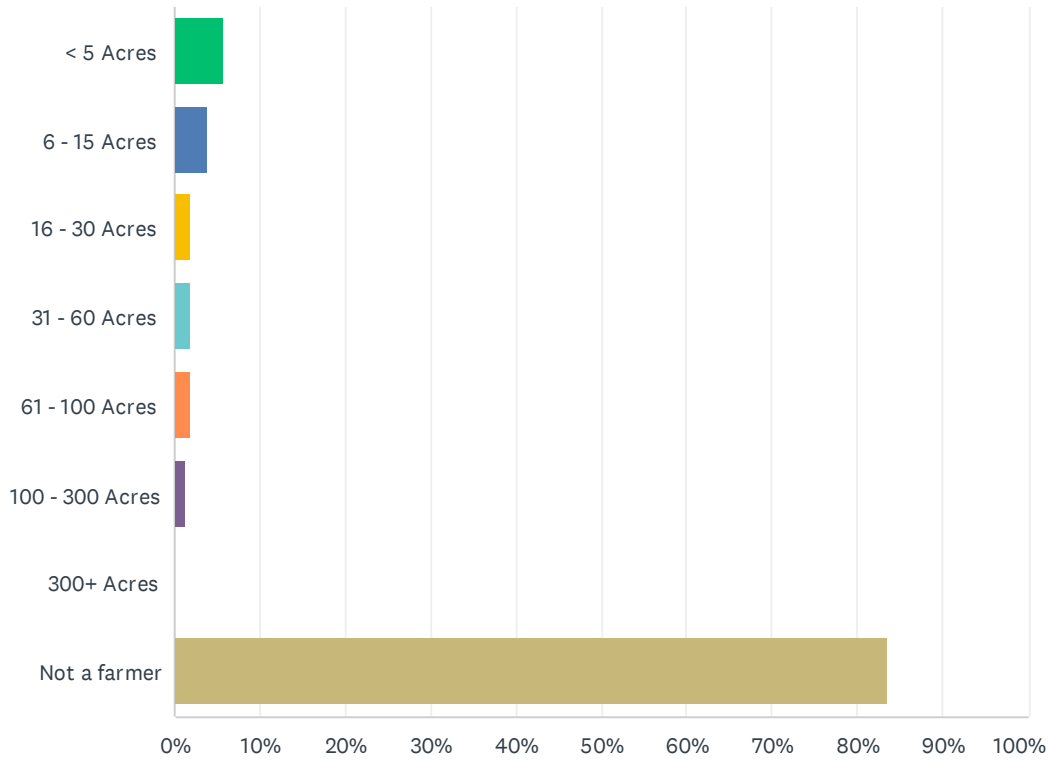

Q9 If you are a farmer, how many acres do you own?

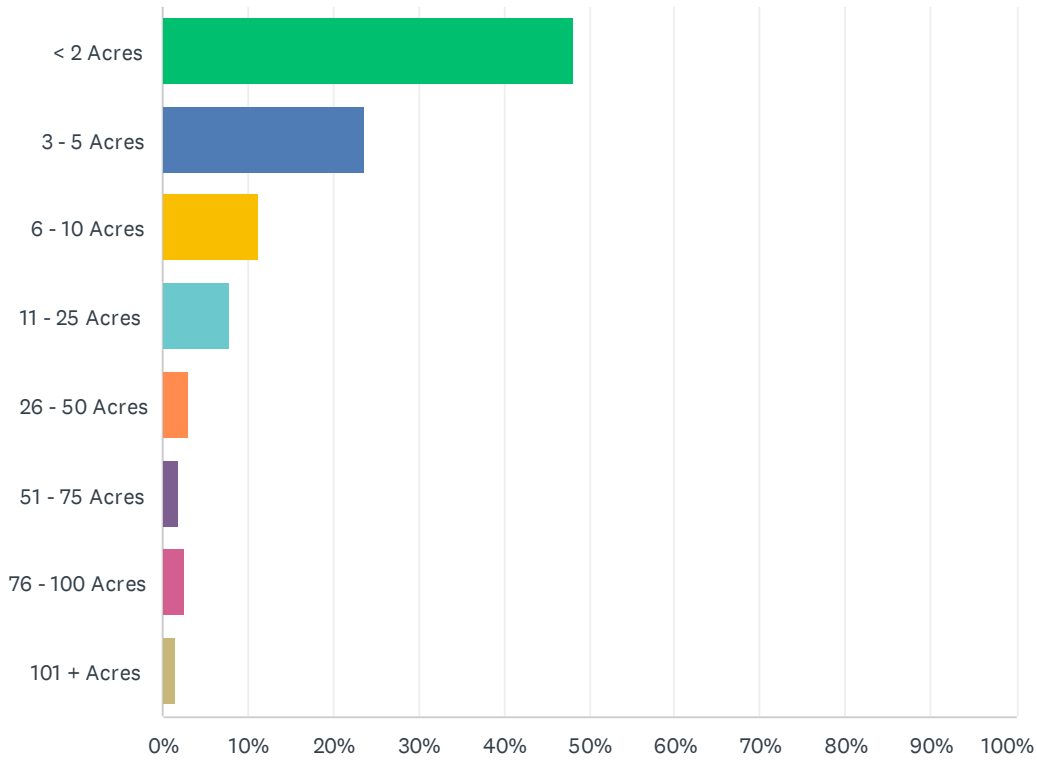

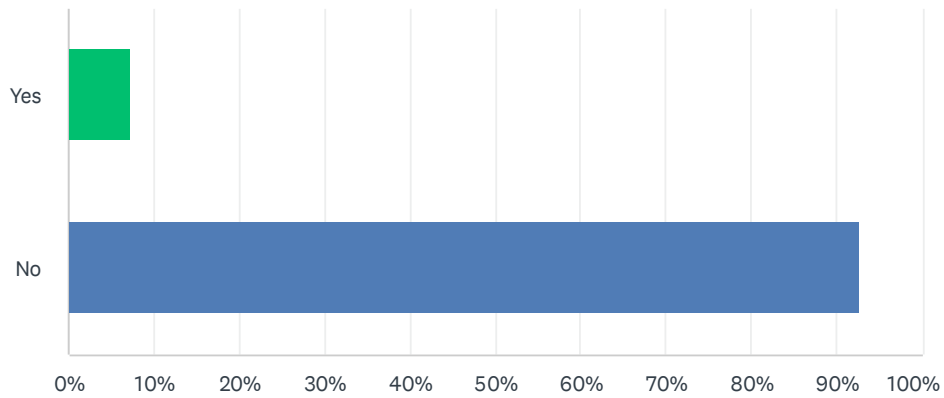

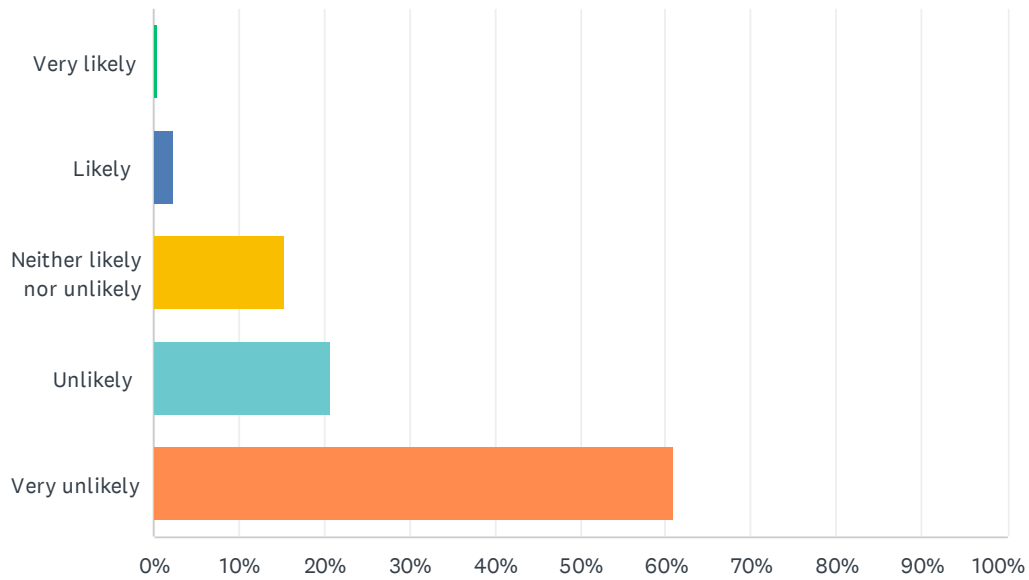

Q12 How likely are you to sell your property in the next 12 months

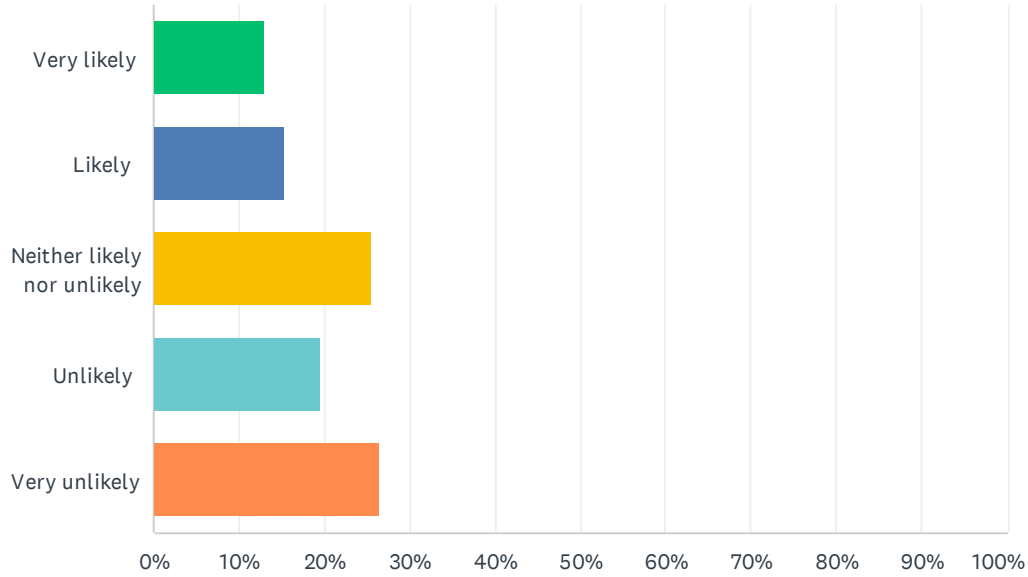

Q13 How likely are you to sell your property if residential development happens near you.

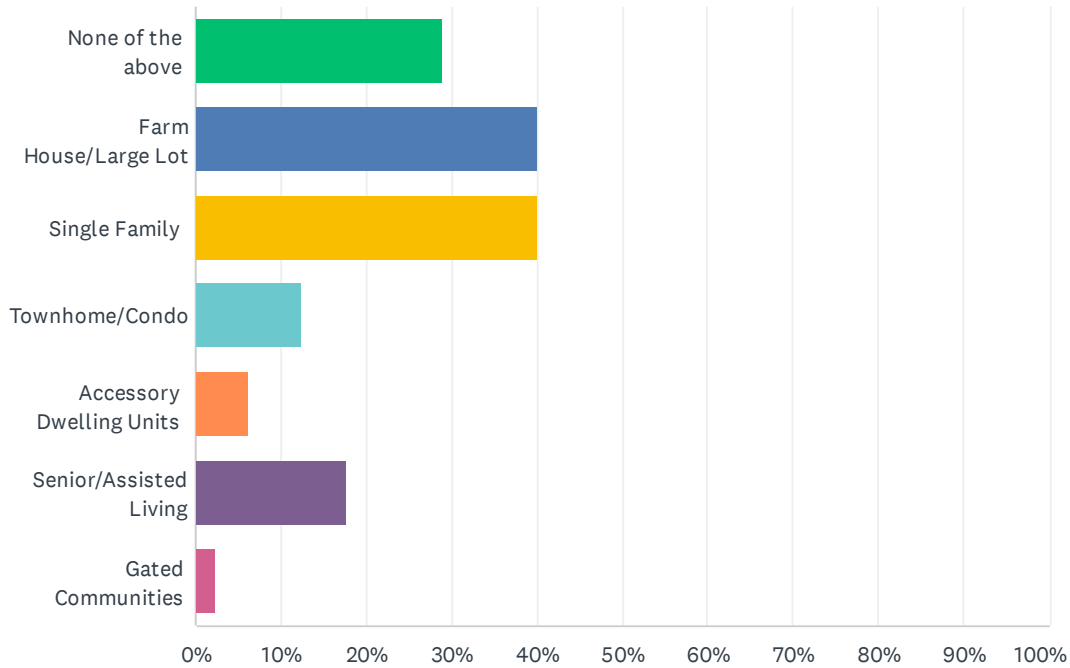

Q14 The Township needs more of which type(s) of housing units? Check all that apply.

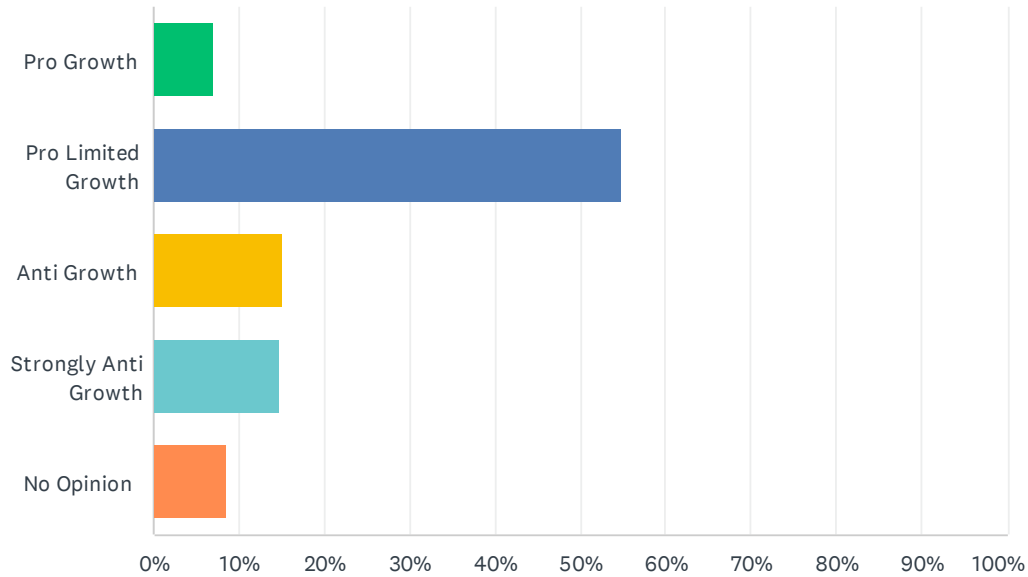

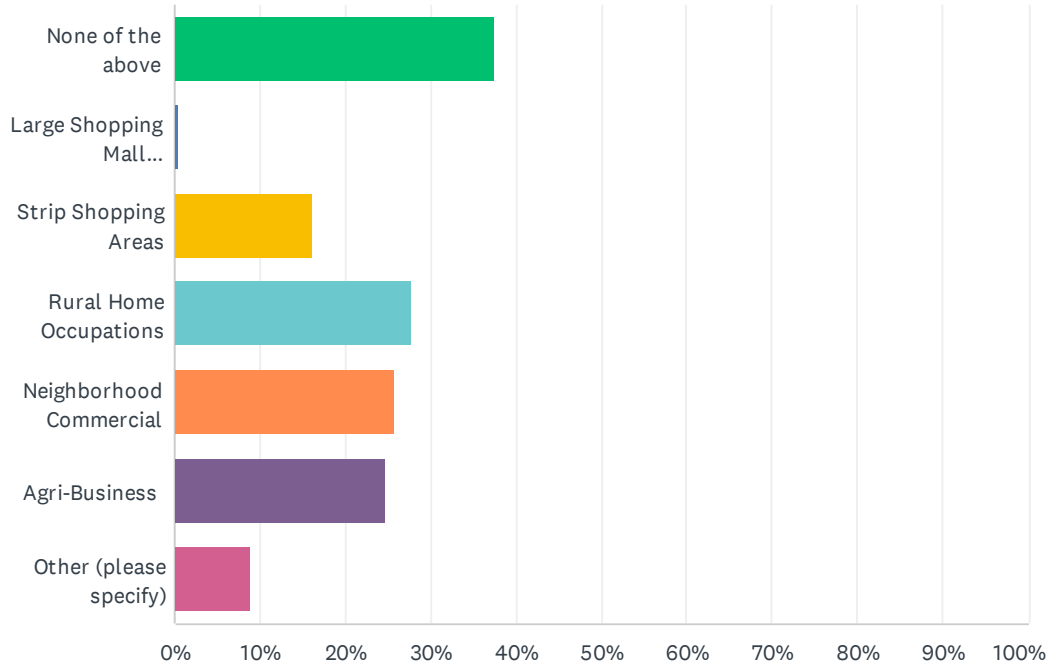

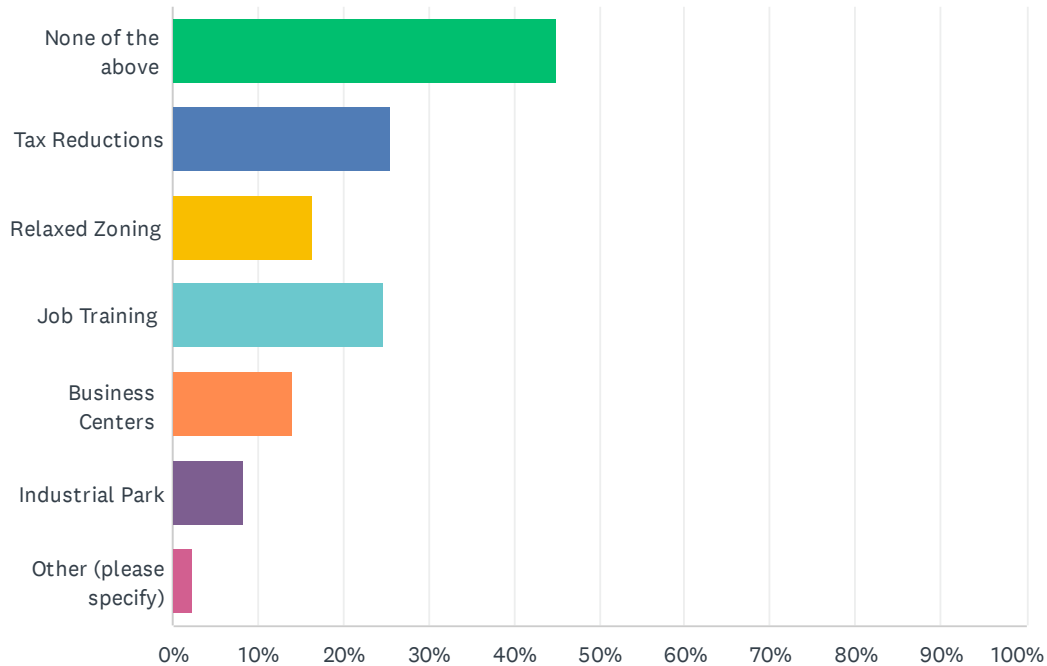

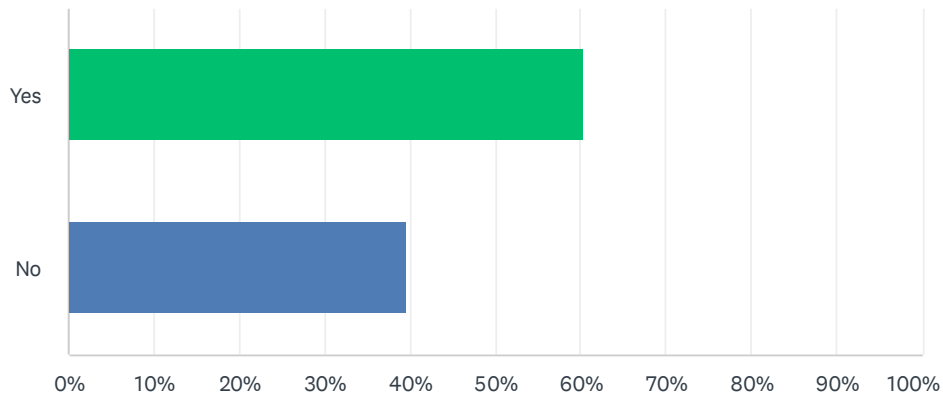

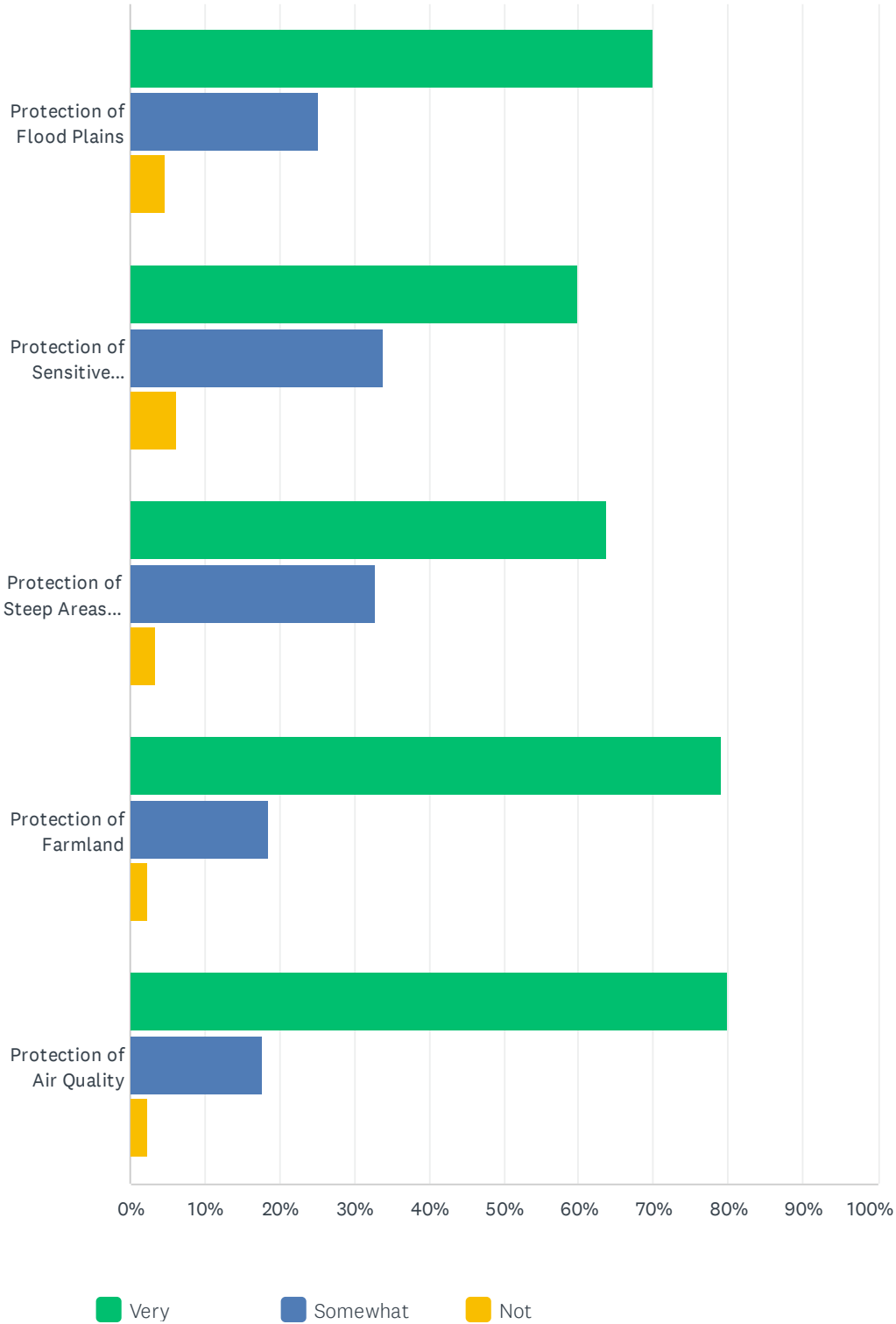

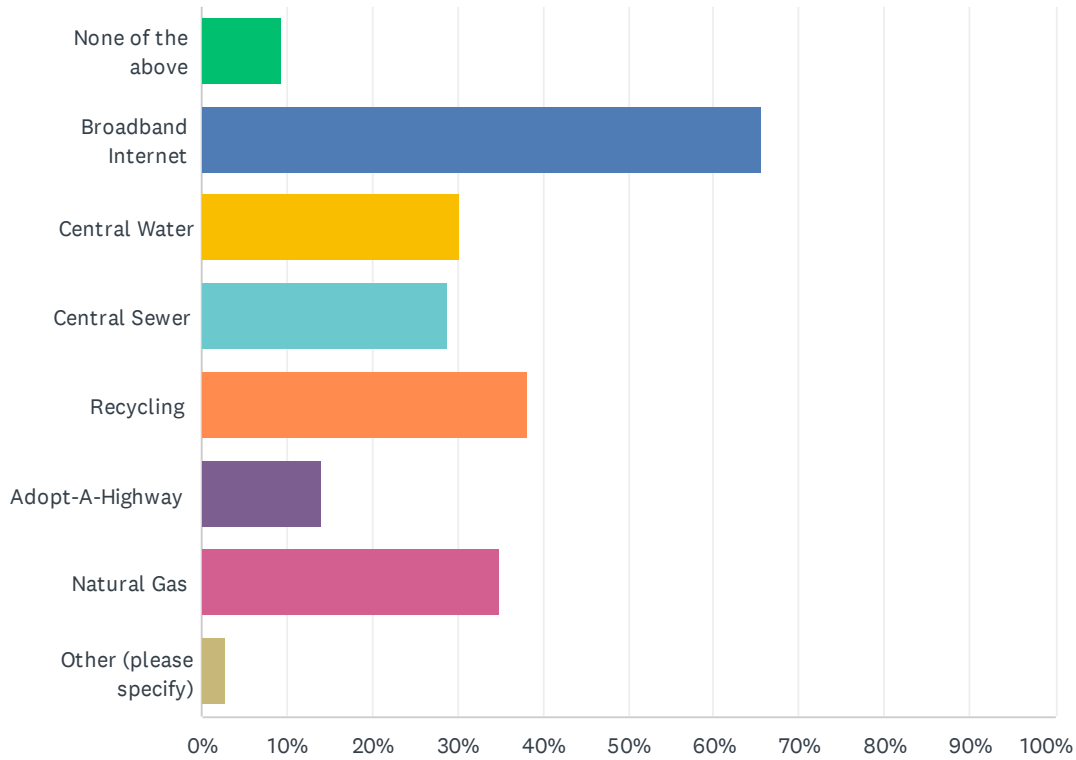

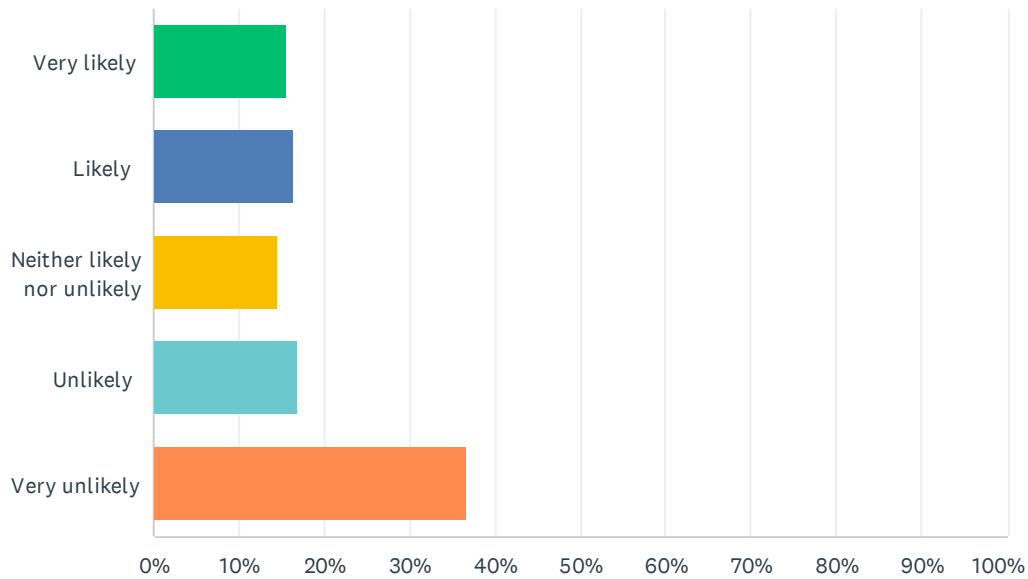

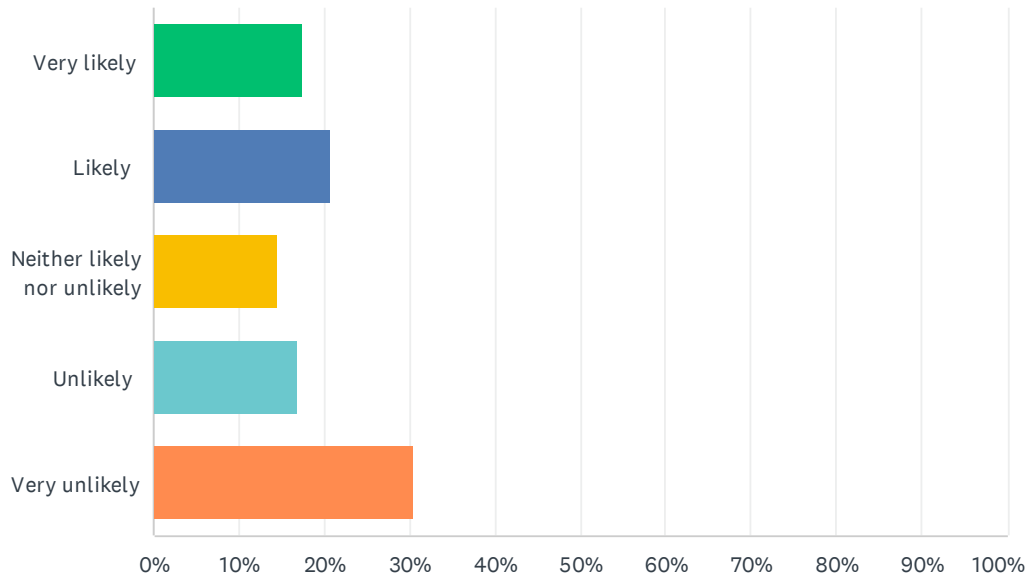

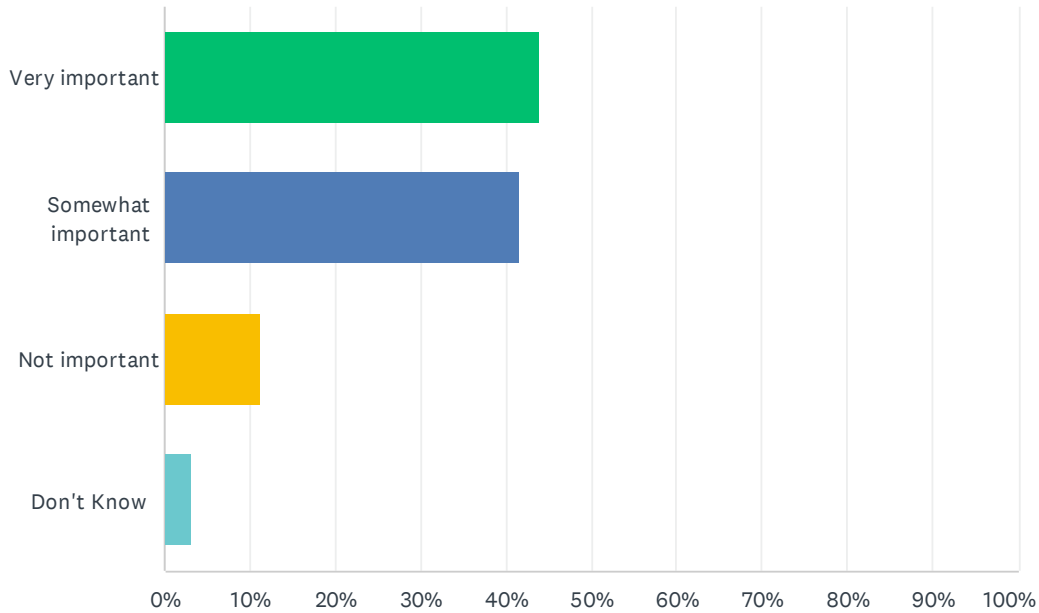

Q27 In your opinion, is it important to work with adjacent communities to coordinate growth?

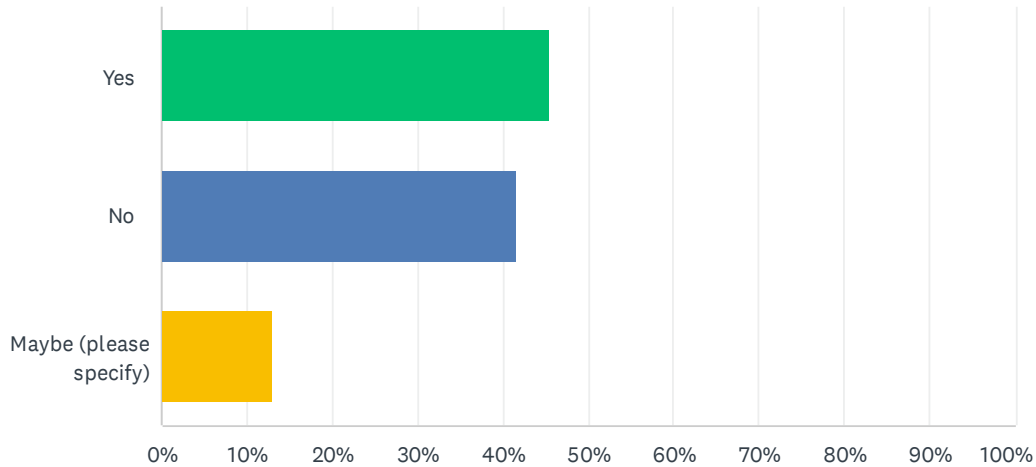
