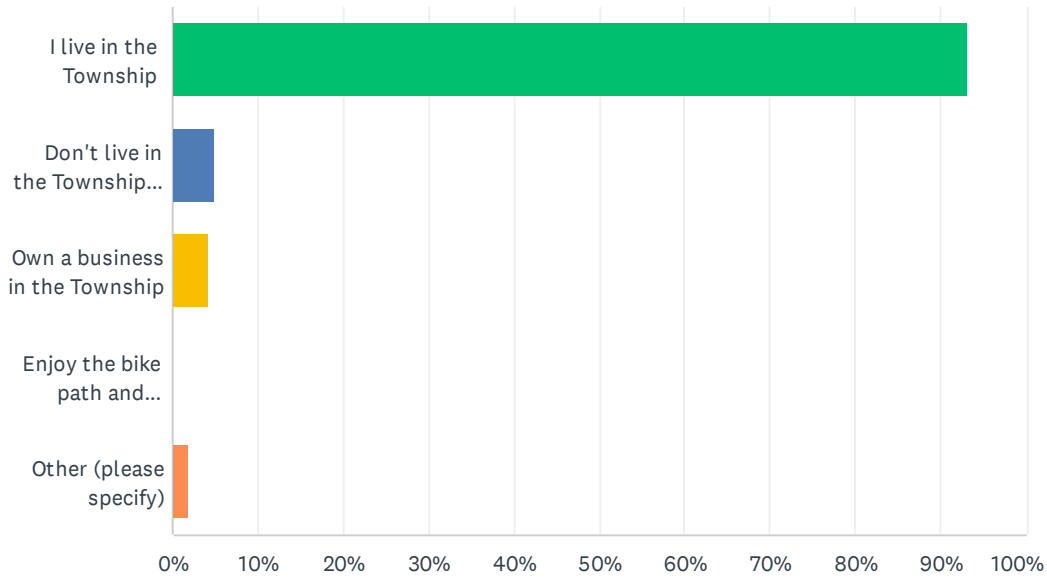


Q1 What is your relationship to Perry Township?

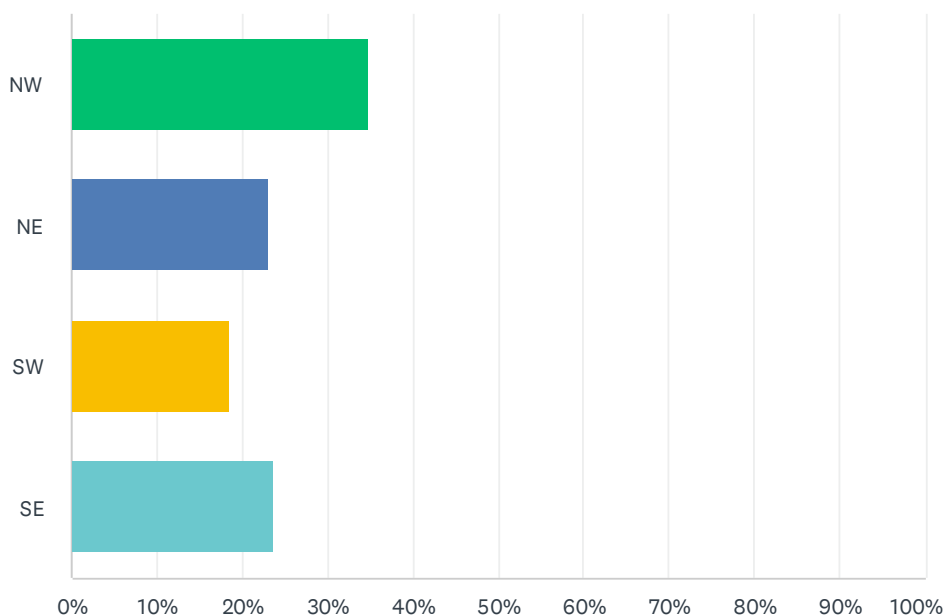

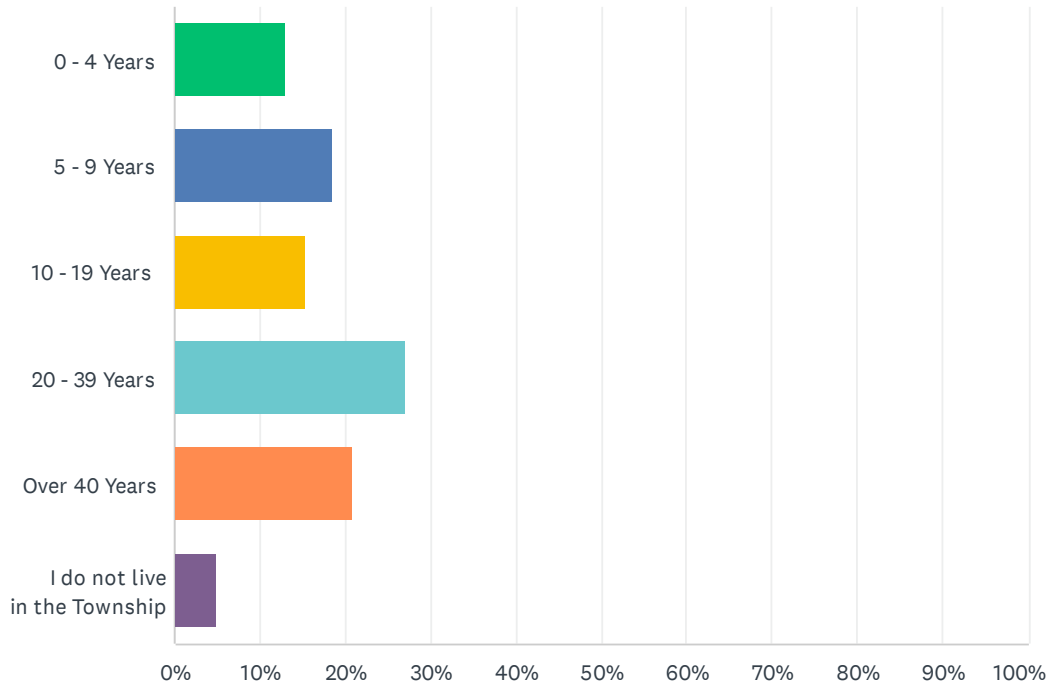

Q3 How many years have you lived in the Township?

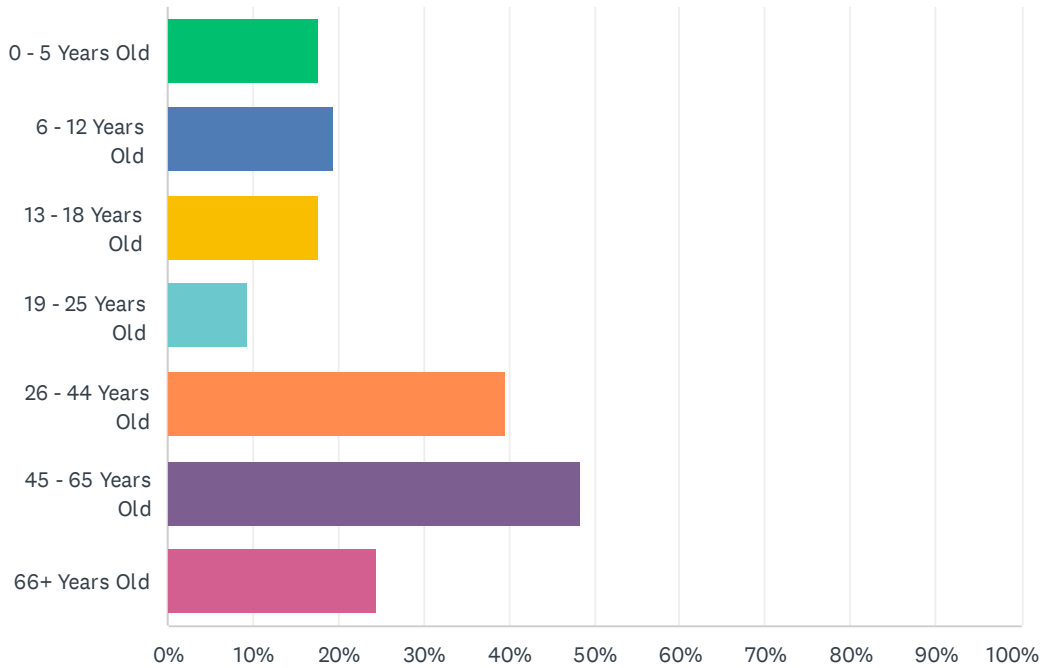

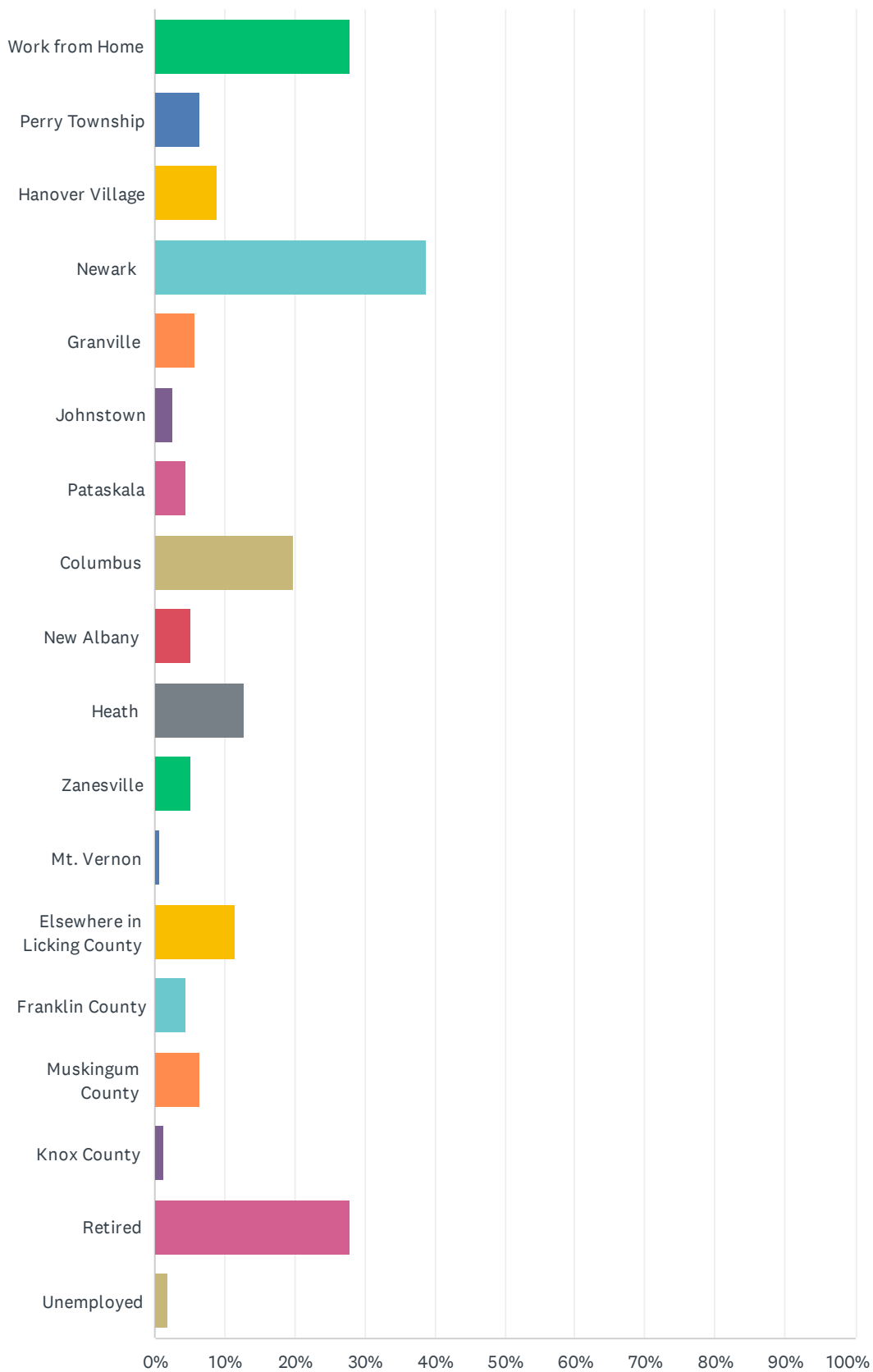

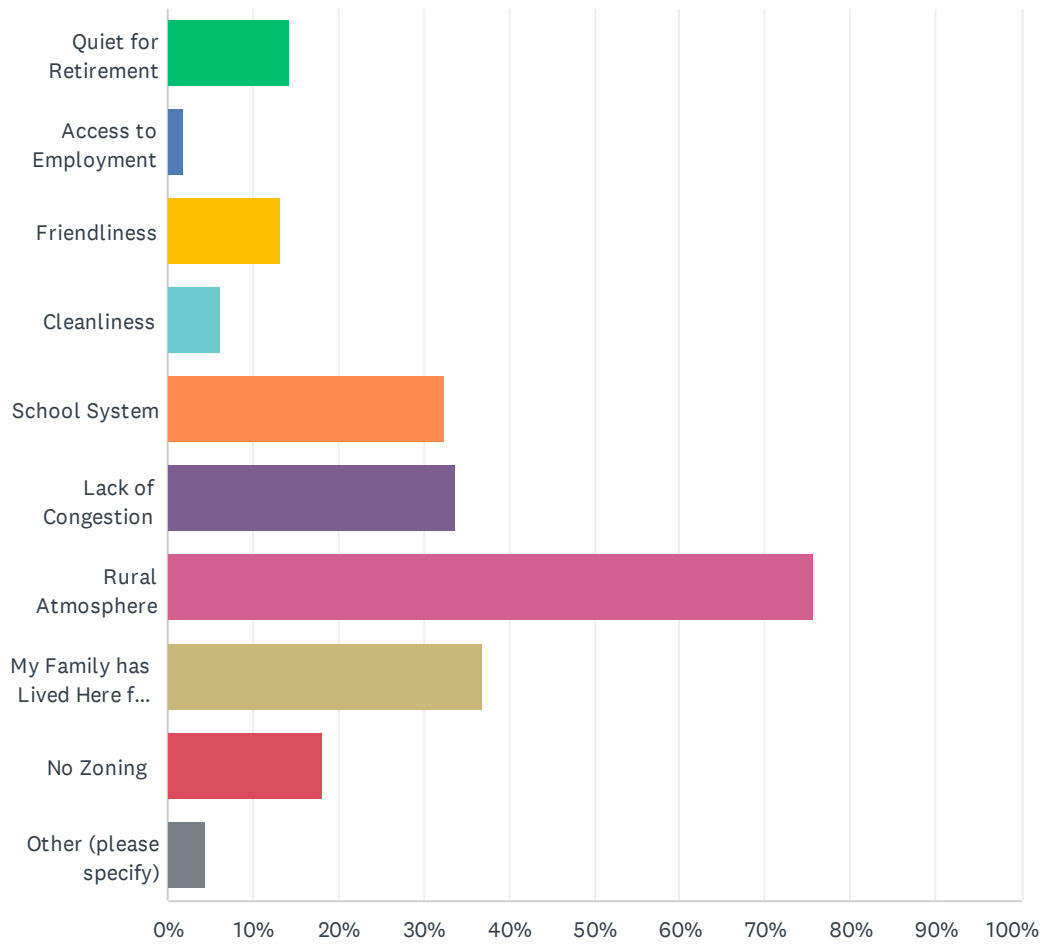

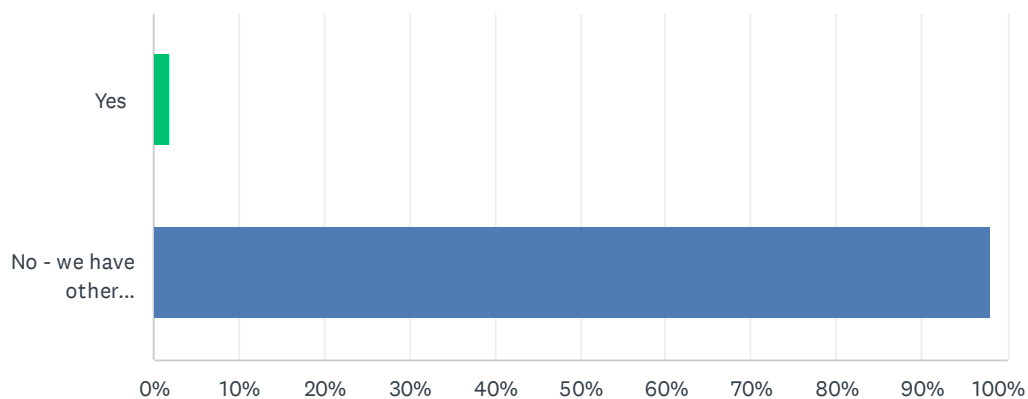

Q7 Is farming your family's primary source of income?

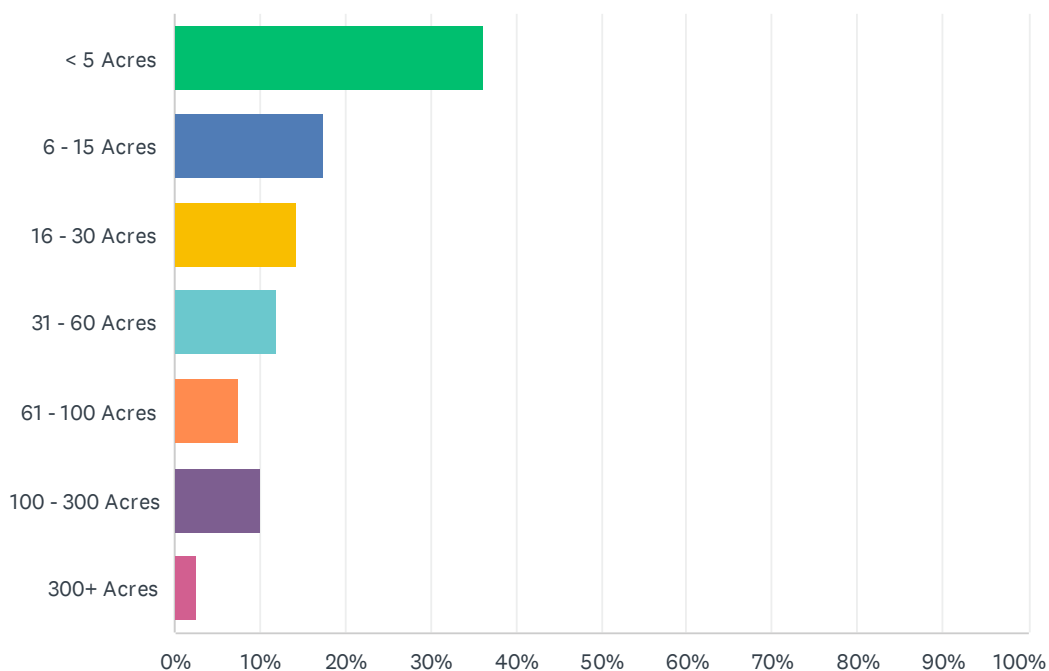

Q8 How many acres do you own?

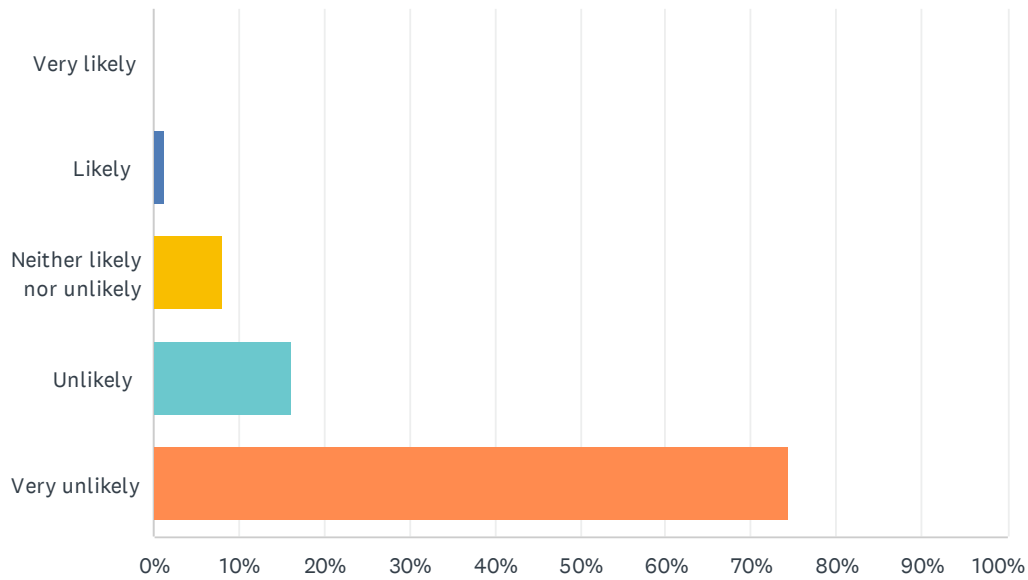

Q9 How likely are you to sell your property in the next 12 months

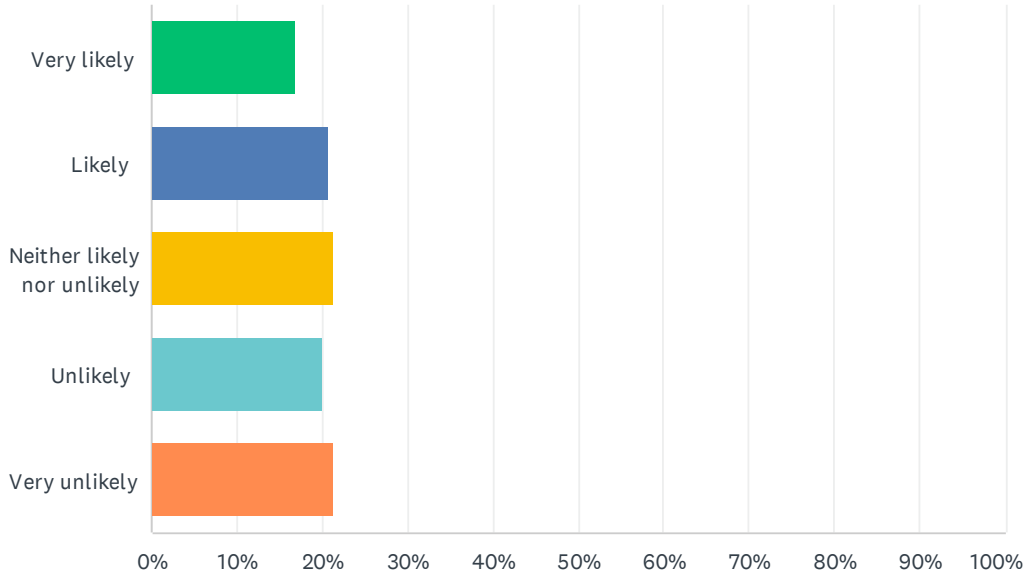

Q10 How likely are you to sell your property IF development happens near you.

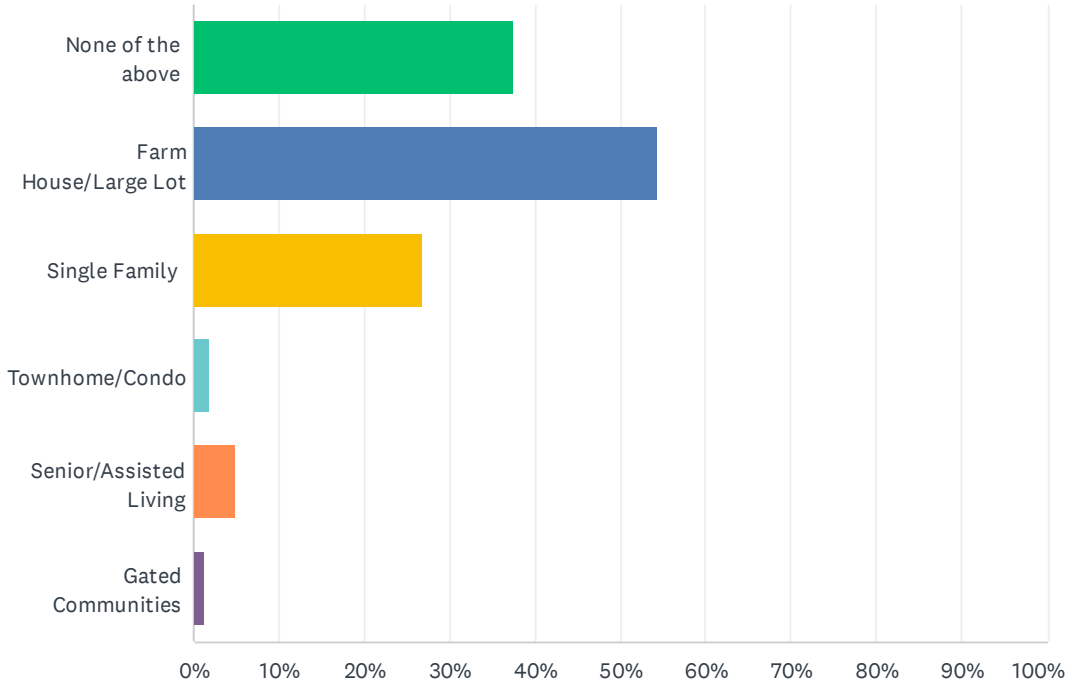

Q11 The Township needs more of which type(s) of housing units? Check all that apply.

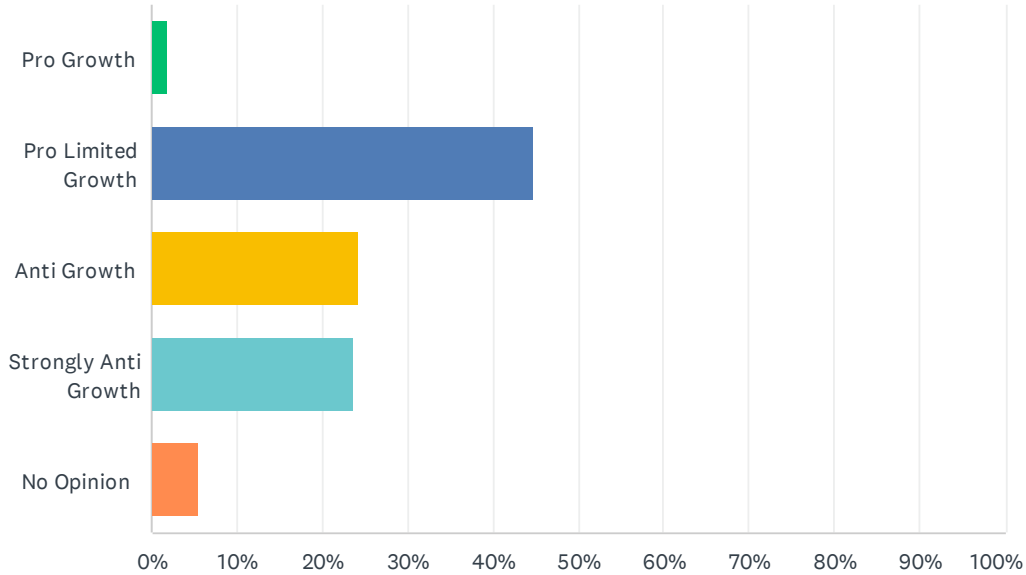

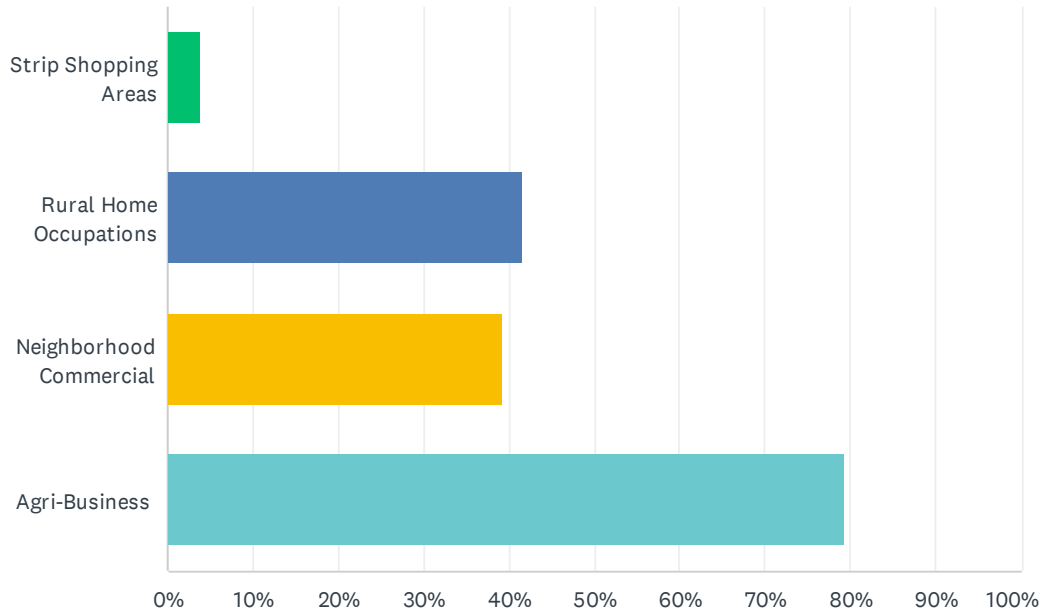

Q13 Which type(s) of commercial development would you like to see in the Township? Check all that apply.

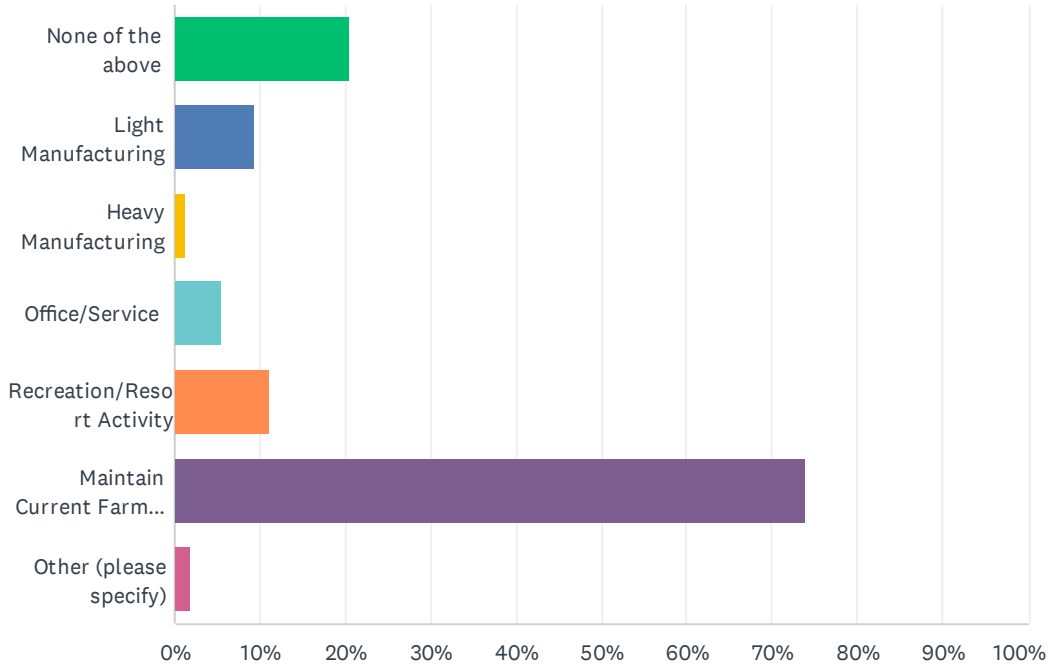

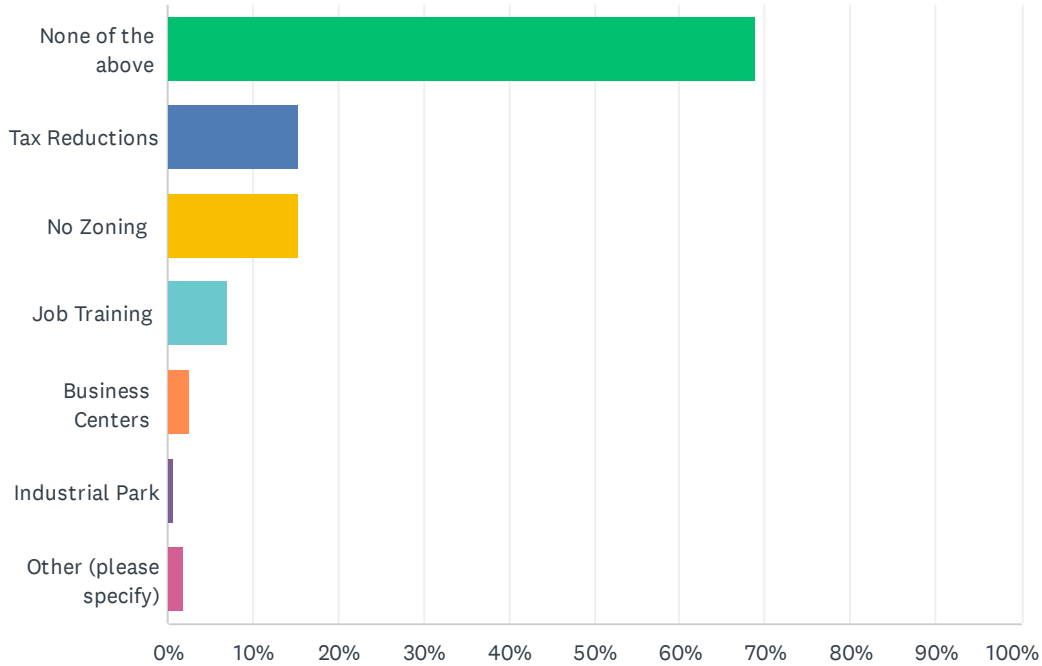

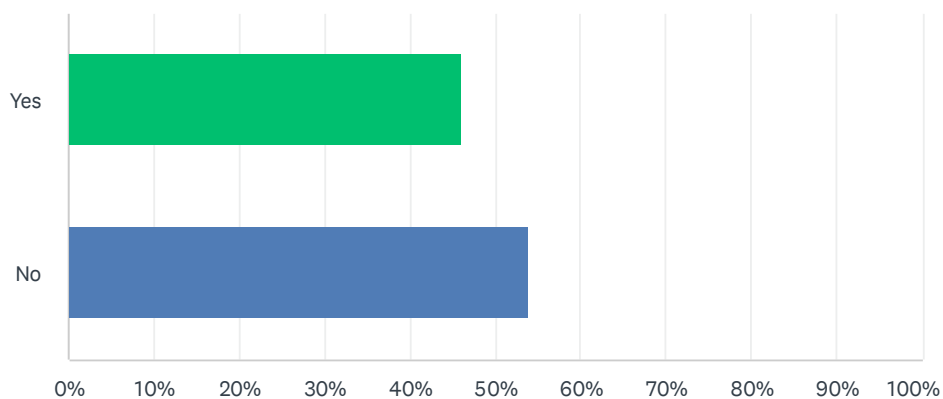

Q16 Would you like to see more public parkland in the Township?

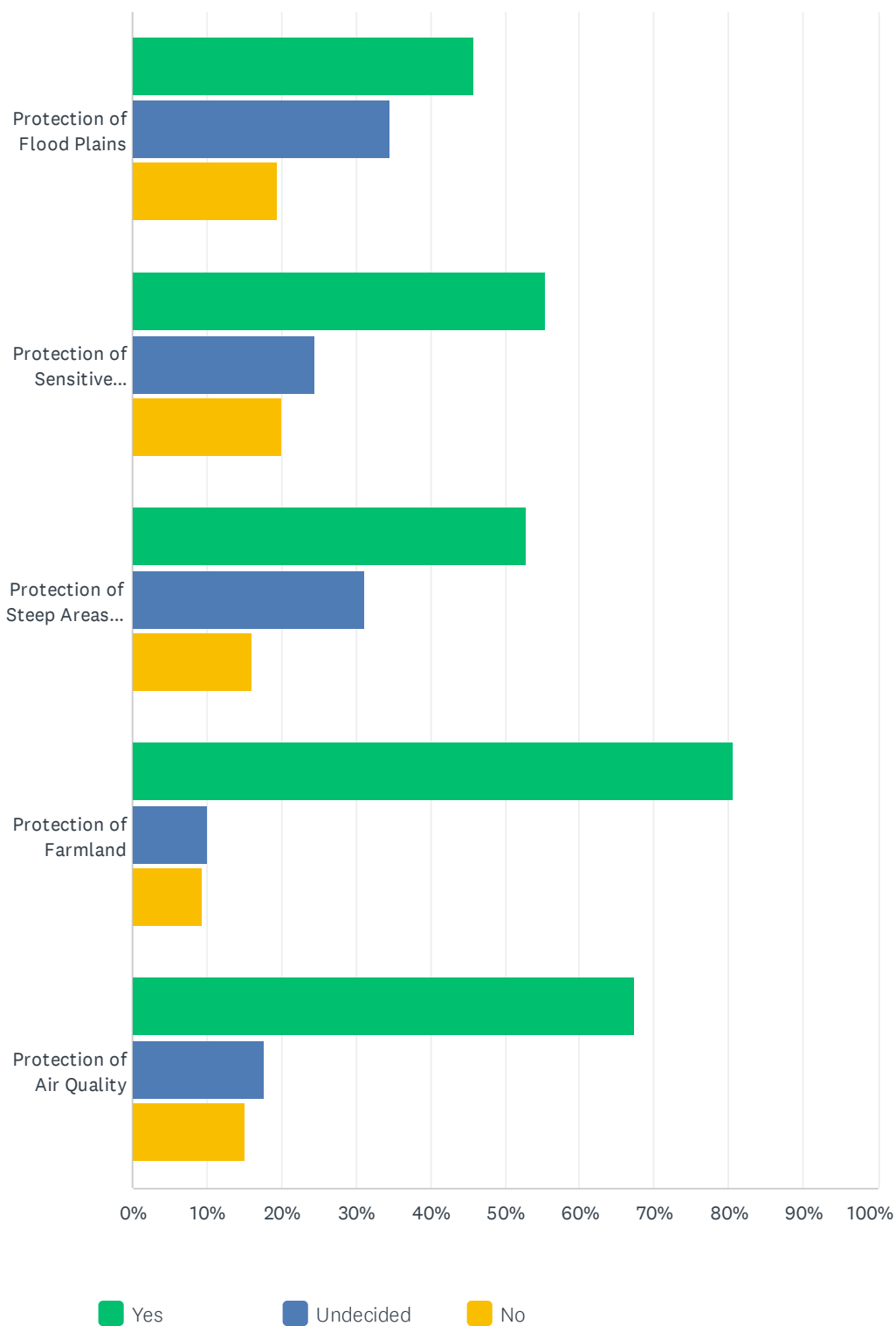

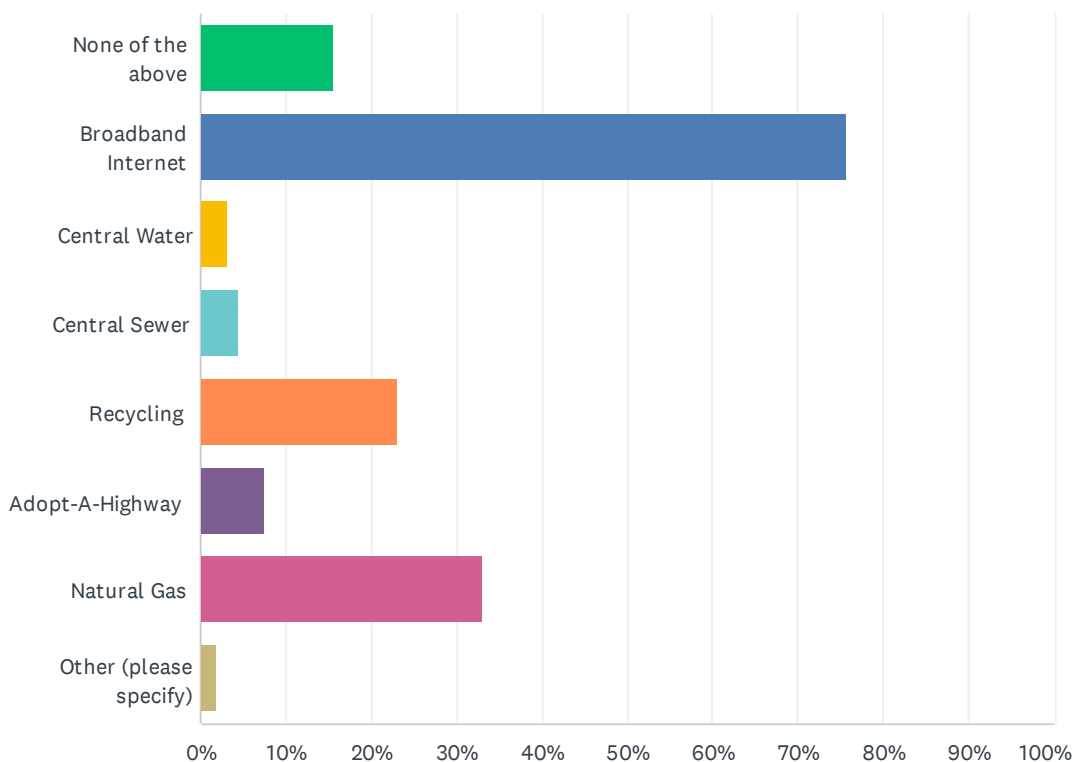

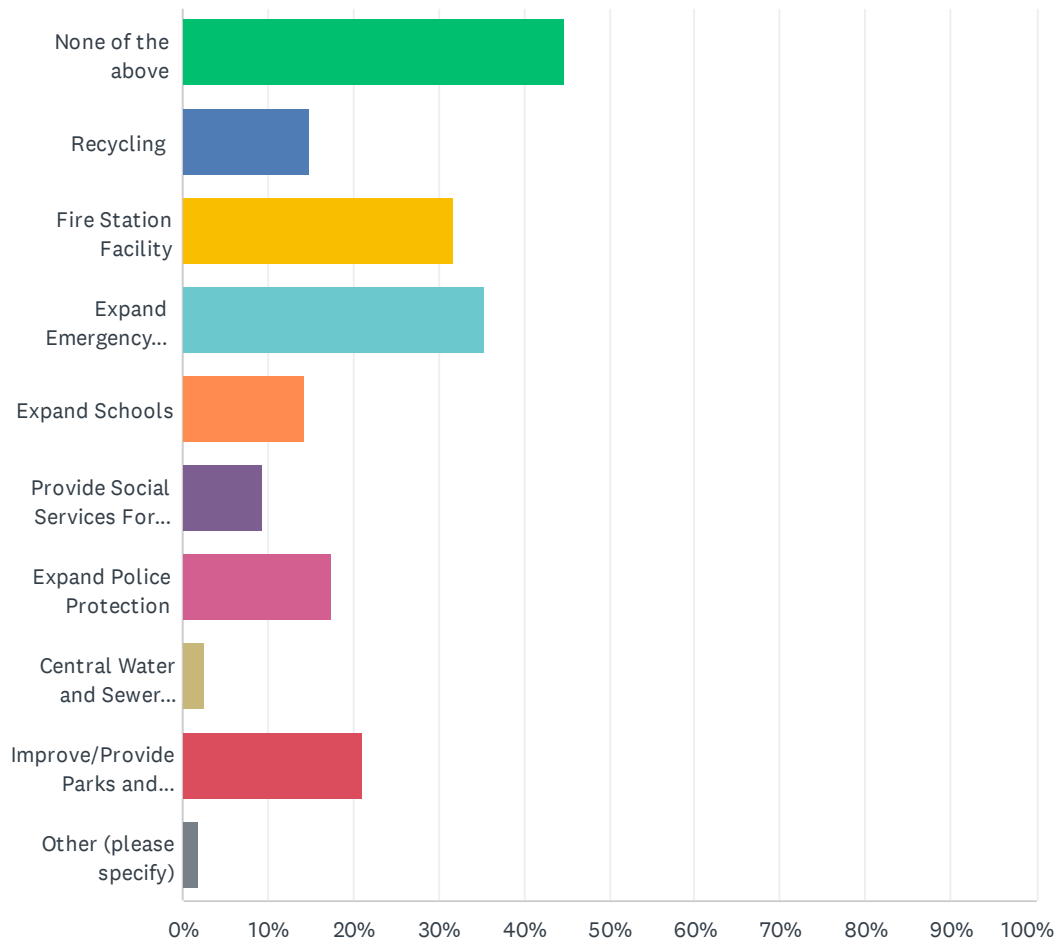

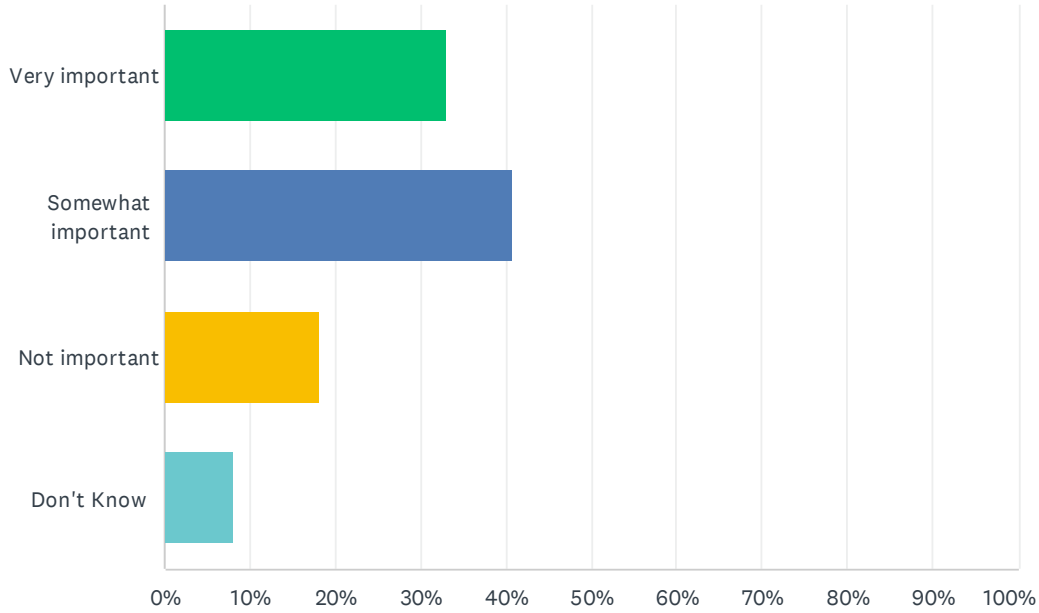
